### **President's Message** by James Smith

I would like to say that it's been a good month, but that would be stretching it. I was involved in a serious car accident on January 30th while on my way to work. A person trying to make a u-turn on Vets hwy clipped the back of my truck, sending me skidding sideways. I smashed into the center guardrail then my truck flipped two and a half times ending up on its roof. Some other drivers stopped and helped me out of the truck (I had to crawl backwards out of the passenger's side window). It was a miracle that I was not hurt any worse than I was, considering the fact that I found myself hanging upside down by the seatbelt. They took me to the hospital, but I was able to walk away from the wreck with only a badly sprained neck and back, a few cuts and some burns on my face (from the impact of the air bag). I am thankful to God that I'm o.k., and that I had dropped Jacob off at his day care center just ten minutes before the incident. I am still having difficulty driving because of limited neck mobility. So far this month, I have only been able to go to work two times.

Let's move on to the real bad news. The Atlantic Marine Fisheries Commission met last week in Alexandria, Virginia and doled out some bad news for New York Fluke fans. The ASMFC found it prudent to adopt the last minute NOAA proposal of 17.122 million pounds for Summer Flounder for the 2007 season. In addition to that, the second shoe dropped with the tallies for last year's recreational Fluke harvest came in. We (NY State) were allotted 650,000 pounds and according their estimates, we actually caught 837,000 pounds of Fluke (which I feel is a real stretch, considering most party boats came back to the docks with pool fish in the 19" range). Whether we agree or not, the ASMFC is requiring New York recreational anglers to take a 49% cut in our quota. Some of their suggested limits were as follows; first is an 18" minimum size, four fish per day and an open season of June 22nd thru July 31st. Second is a 19" minimum size, 4 fish per day and an open season from May 6th thru August 31st. The final suggestion is a 20" minimum size, four fish per day and an open season of May 1st thru September 31st. Any of these solutions are not very appealing.

The ASMFC has also laid down tougher limits for Blackfish and Weakfish for the 2007 season. I will keep you posted regarding the new regulations as they become available.

## Outdoor by Jason Remien

Board members discussed the approved tournament schedule for 2007. Additional information on each tournament (e.g., time limits, weigh-in locations, etc.) will be made available to club members on the website and in future newsletters as the tournaments draw near. The following changes/updates were discussed for a few of the tournaments:

- The North Shore Fluke Tournament will be held on Friday and Saturday, June 15<sup>th</sup> and 16<sup>th</sup> instead of Saturday and Sunday, June 16<sup>th</sup> and 17<sup>th</sup>. This change was proposed to avoid having the second day of the tournament on Father's Day.
- The prizes for the Peconic Tournament were changed as well. There will be a 1<sup>st</sup> and 2<sup>nd</sup> prize for three fish species (weakfish, fluke, and bluefish). If any one of the species is not caught on the day of the tournament a 3<sup>rd</sup> place prize will be included for one or more of the other categories.
- The blackfish tournament will be on Saturday, November 3<sup>rd</sup> on the Orient Star II (Captains Bill and Mike Russo).
